I, Keith Henderson, Assistant District Attorney of said County, being duly sworn on oath state to the Court that

MICHELLE L. PRESTON

did the following:

COUNT I -- That on or between the 1st day of September 2010 and the 31st day of December, 2010 in the City of Lenexa, County of Johnson, State of Kansas, did then and there unlawfully, knowingly, willfully and feloniously engage in consensual sexual intercourse, lewd fondling or touching, or sodomy with [REDACTED], who is not married to MICHELLE L. PRESTON when MICHELLE L. PRESTON was a teacher and [REDACTED] was a student enrolled at the school where MICHELLE L. PRESTON was employed, a severity level 5 person felony, in violation of K.S.A. 21-3520, K.S.A. 21-4704 and K.S.A. 21-4707. (unlawful sexual relations)

COUNT II -- Further, that on or between the 1st day of September 2010 and the 31st day of December, 2010 in the City of Lenexa, County of Johnson, State of Kansas, did then and there unlawfully, knowingly, willfully and feloniously engage in consensual sexual intercourse, lewd fondling or touching, or sodomy with [REDACTED], who is not married to MICHELLE L. PRESTON when MICHELLE L. PRESTON was a teacher and [REDACTED] was a student enrolled at the school where MICHELLE L. PRESTON was employed, a severity level 5 person felony, in violation of K.S.A. 21-3520, K.S.A. 21-4704 and K.S.A. 21-4707. (unlawful sexual relations)

COUNT III -- Further, that on or between the 1st day of September 2010 and the 31st day of December, 2010 in the City of Lenexa, County of Johnson, State of Kansas, did then and there unlawfully, knowingly, willfully and feloniously engage in consensual sexual intercourse, lewd fondling or touching, or sodomy with [REDACTED], who is not married to MICHELLE L. PRESTON when MICHELLE L. PRESTON was a teacher and [REDACTED] was a student enrolled at the school where MICHELLE L. PRESTON was employed, a severity level 5 person felony, in violation of K.S.A. 21-3520, K.S.A. 21-4704 and K.S.A. 21-4707. (unlawful sexual relations)
