On 08-21-12 victim [redacted] came into the Sheriff's Office with his mother [redacted] to file a report of a sexual assault committed on her son [redacted] is a 16 year old student at Bethel School and Wendy Hickman DOB 12-02-71 was his English teacher. [redacted] told Carnell that he had sex with his high school teacher, Hickman, from Bethel School at his home located at [redacted] with Pottawatomie County, around the end of July 2012. [redacted] said Hickman performed oral sex on him and then they had vaginal sex. [redacted] said that Hickman has been sending nude pictures of herself and text messages from her phone which is a Apple I-Phone with the phone number of [redacted] Carnell viewed the photo's and it shows Wendy Hickman with her pants down, fondling her vaginal area. The photo shows Hickman's face which was compared to Hickman's face book page, and Superintendent Johnson with Bethel School identified the photos on [redacted] phone to be Hickman. [redacted] said that he only had sex with her that one time. [redacted] also said that Wendy Hickman has a scar on her lower belly and her vagina is shaved. [redacted] said that he used a condom but she told him he did not need one because she is fixed.
